

Office Order

Subject: REGARDING EXPORT OF DRUGS WITH NEUTRAL LABELS EXEMPTION UNDER RULE 94 OF THE DRUGS AND COSMETICS RULES AS AMENDED.

Please refer to the subject cited above.

It is mentioned that the Drug Controller General (India) had intimated vide letter no. X.11038/46/88-D dated 23.06.1988 that the manufacturers of drugs, who desire to export drugs without indicating the name and address of the manufacturer on the label have to indicate these particulars in the form of a code. The code that has been approved by the Drugs Controller (I) is the abbreviation of the State followed by the word Drugs and the Drug Manufacturing License number. Thus a drug manufacturer in Haryana would indicate on the label the words "code no. HR/DRUGS/Drug Manufacturing License Number." The abbreviations to be used for the various states are given the enclosed statement.

In view of the above it has been decided that the manufacturers need not apply for code no. for export of drug to be exported and they can suo-moto use the code no. as mentioned in the preceding Para and the documents enclosed. In future no separate application for this purpose will be entertained by this office and this letter be treated as permission for grant of code no. for export purpose.

EXPORT OF DRUGS WITH NEUTRAL LABELS EXEMPTION UNDER RULE 94 OF THE DRUGS AND COSMETICS RULES AS AMENDED.

It may be stated that the Rule 94 of the Drugs and Cosmetics Rules has since been amended under the Ministry of Health and F.W. Notification No. X. 11914 / 2 / 87-DMS and PFA dt. 2.6.88 published in the Gazette of India, Extraordinary Part II Sec. 3(1) under G.S.R. No. 676(E) dt. 2.6.88 providing for the labelling of the package or containers of the drugs intended for export to be adopted to meet the specific requirements, if any, of the consignee subject to certain conditions. The following provision has been added to Rule 94 by the notification mentioned above.

"Provided that where a drug, not classified under Schedule F, Schedule F(1) and Schedule X, blood products, Narcotic and psychotropic substances is required by the consignee to be not labelled with the name and the address of the manufacturer, the label on the packages or containers shall bear a code number as approved by the licensing authority mentioned in Rule 21".

In view of the above, the manufacturers of drugs in Your State, who desire to export drugs without indicating the name and address of the manufacturer on the label should indicate these particulars in the form of a code. The code that has been approved by the Drugs Controller (I) is the abbreviation of the State followed by the Word DRUGS and the drug manufacturing licence number. Thus a drug manufacturers in Tamil Nadu would indicate on the label the words "code No. T.N. / DRUGS / Drug manufacturing licence Number". The abbreviations to be used for the various States are given in the enclosed statement. This may kindly be brought to the notice of the manufacturers of drugs in your State.
